Once again, Julian has graciously agreed to host a "Video Madness Party" at his Georgetown home. This one will take place on November 4th; and the video-theme for the party will be "horror"! (It's our slightly-belated Halloween celebration!) So, on Saturday, November 4th, plan on getting together with all the rest of us who've been infected with the "video madness" bug over the years! Here are the details on how to join in the fun:

#### When?

Saturday, Nov. 4th: "The doors open" at 3:00 PM and the videos will probably begin about 4:00 PM. The party will last until "late evening sometime".

#### What to Bring?

Bring along your favorite horror-themed videos. Attendees will vote on which videos will be shown at the party. (There'll be a couple of different "tracks" of programming in different parts of the house.)

The party will, of course, include a pot-luck meal, so bring along something scrumptious to eat. We're not pre-assigning categories of what food to bring, so everyone should just bring something from one (or more) of the following "basic food groups": appetizers (veggies, chips, etc.); a main course (enough to serve at least 4-5

people); dessert (of course!); non-alcoholic drinks (both diet and regular).

#### **How to Get There?**

The party will be held at Julian's home in Georgetown (site of numerous LSF "Video Madness" parties in the past). It's located at 1928 37th St., NW, several blocks west of Wisconsin Ave.

#### By Metrorail/Metro-

bus: Take the Red line to Dupont Circle. Exit at either side of the station; then head for the part of P Street west of the Circle. (That's the part with all the bars, restaurants, etc.). Go to the 2nd Metrobus shelter from the Circle (across the street from Oasis Deli and Pan Asian Restaurant) - NOT the first one, which is in front of the old public restrooms. Take the D2 Metrobus, which will stop just up the street from Julian's house. Or, you can take the D4 and get off at R & 37th streets (about 5 blocks from Julian's). For the bus schedule, call Metro information at (202) 637-7000.

Driving, from the North: Going south on Wisconsin (from the direction of National Cathedral), you'll pass Mass. Ave. Just after Calvert St., 37th St. splits off to the right from Wisconsin (as Wisconsin swerves to the left). In about a half mile, 37th St. passes through Whitehaven Park and intersects White Haven Parkway. Julian's place is just beyond White Haven Parkway, on your right.

Driving, from the South: Going north on Wisconsin (from the direction of "M" St.), you'll need to take a left on some street to get to 37th St. If you turn left on Reservoir Rd. or on "R" St., you'll need to turn right on 37th St., and Julian's place will be a ways on your left. If you go further up Wisconsin to White Haven Parkway (near the "social Safeway"), you'll turn left on White Haven Pkwy. and then left again on 37th St. Julian's home will be on your right.

Where to Park: Your best bet for parking is either along White Haven Parkway or along "T" St.

### X-Men: A Brief Review



### Two Book Reviews by Colleen R. Cahill

### Tangled Up in Blue by Joan D. Vinge (New York: Tor, 2000)

In this prequel to The Snow Queen and The Summer Queen, Joan Vinge focuses on the planet Tiamat and, specifically, the city Carbuncle. Tiamat is the backwater of this universe, with its only export being the Water of Life, which can provide eternal youth. Carbuncle is the capital and only city on Tiamat: it is a paradox of beauty and crime. Readers of her previous titles will be familiar with many of the characters Tangled Up in Blue: Jerusha PalaThion, Mundilfoere, Humbaba, the Source, Herme and Arienrhod (the Snow Queen herself) all appear in more than cameo roles. But the main story line revolves around Nyx LaisTree, a Hegemonic police officer and his eventual partnership with a new Hegemonic Sergeant, BZ Gundhalinu. The interaction between these men, both as adversaries and allies, demonstrates Ms. Vinge's ability to create deep and believable characters. The size of Tangled Up in Blue is less than its companion novels and so is its scope. Rather than spanning years and worlds, Ms. Vinge keeps the entire storyline in Carbuncle and only covers a few months' time. Described as a "noir future thriller" on its blurb, the book does has the dark feeling of a Humphrey Bogart film. Frustrated by their inability to prevent smuggling in Carbuncle, a group of patrolmen begin vigilante-style raids of warehouses they know contain contraband materials. After a few months of success, the group is ambushed and all but Nyx are killed. On suspension and under suspicion, Nyx is driven to find out who killed his fellow patrolmen, one of whom was his brother. Nyx is aided by the beautiful Devony Seaward, a shapeshifter who, through technology, can change her appearance to be anyone. Like many of the people Nyx deals with, her motives and loyalties are often at question and Nyx is not sure which is planet she is from. Devony is much like Carbuncle, a

### Of Swords and Spells by Delia Marshall Turner (NY: Ballantine, 1999)

Of Swords and Spells is a book that defies definition as a science fiction or fantasy novel. On one hand, it has space ships, needle guns, and a galactic web; on the other hand, it also has magic, witches, and sword play. Turner has made both science fiction and fantasy commonplace in her universe; and they interact together in a way that does not jar the mind. Magic is a source of power -- not just for spells, but for engines that drive space ships.

At the center of the story (and its narrator) is Malka, a short, cranky, sword master who is on the run from both the galactic magic police and her mysterious master. Malka is just as mysterious, as she has magical powers but insists she is not a witch, seems to be

interesting paradox looking for a purpose. Eventually, everyone in the story is looking for a jewel (the Maltese Falcon of the book) which is an old Empire artifact, although no one will say why or what it does. Several characters belong to the Survey, a Masonic-like secret society whose agenda is often unclear. This is in part because within the Survey are several factions, some of which are at odds. But these elements do not make the story confusing, only more mysterious and compelling. As hints, clues, and red-herrings appear, a more complex picture forms. The ending has an interesting twist; and, if you have not read the other works in this universe, you may find yourself compelled to hunt up the other titles. Any fan of the "Snow Queen cycle" should read this book: you can get your Vinge fix and also find out a bit more about the continuing characters. For anyone who has not read Ms. Vinge's works, this title is a good starting point, as it can be read without any knowledge of the other two books and is much shorter -- the hardback being only 235 pages long. In either case, this work is a page-turner and well worth a read. ΑΨΦ

15 years old but has memories of several decades, and attracts the most unusual people. She deals with or tries to avoid a fencing master, a handsome android, various witches, an extremely nasty-sounding master, a possessive cat, and a group of people who want to "release" her, which she implies is not a good idea ... for her.

The book begins with the sword fight between Malka and her trainer Sefir Zul. As one of the two major sword fights in the book, it sets the tone of Malka's relationship with the world. She trusts no one, likes to hurt people, and wants to be left alone; but it is quickly revealed that she may not just be a paranoid, sadistic loner. The title of each chapter is a fencing term or phrase, reflecting not only the ability of Malka with a saber but that of the author, who is a national-ranked saber champion.

The titles also nicely reflect the action in the chapter, but do not give anything away.

The most intriguing thing about this book is the way the author sets expectations and then turns the story away from them. Malka is especially hard to pin down, as her character and even her physical size are in flux. Hints are dropped; but just when you think you have enough pieces to put the puzzle together, a new clue will reshape the picture. Not being cruel, Turner does eventually answer the most burning questions and nicely joins this book to Nameless Magery, an earlier work set the same universe. For those who have read the first book, Of Swords and Spells gives a different but still familiar view of that world and has appearances of some of Nameless Magery's characters.

My personal assessment of the book is that it is a fun read, with plenty of plot twists and interesting characters. While this work may not change your world view or deepen your spiritual nature, it will keep you entertained.

## Proposal - Officers (to be voted on at the Nov. 12th LSF meeting)

LSF will have five officers, elected by the membership for a term of one year, to begin on January 1st immediately following elections. Officers must be members of LSF. Elections for all officers will be held annually at the regular December meeting of LSF. Officers may serve for any number of terms. An individual may not hold more than one office at a given time. Candidates must announce their desire to run at or before the November LSF meeting. Candidates are encouraged to submit platform and qualification statements in writing to the Newsletter Editor in time for the December newsletter.

All elected officers must keep records of correspondence and samples of materials used in the performance of their office and make these available for review as requested. All officers must insure that all data relevant to their office is backed up regularly offsite.

The five officers are:

SPEAKER: Presides over LSF meetings and insures that the club is informed regarding the enactment of club decisions.

TREASURER: Manages, monitors, and reports on the financial activities of the club. Reports monthly on the club's financial status. Provides detailed written reports annually and as requested. Insures that club bank accounts have multiple signatories, who shall be


officers of the club and who cannot all reside at the same address.

MEMBERSHIP COORDINATOR: Manages incoming mail. Maintains LSF membership database. Generates mailing labels and renewal notices for mailings. Generates regular membership directories. Generates membership list and insures that a current membership list is available at each regular meeting. Creates membership inquiry packets and responds to membership inquiries. Produces LSF membership forms and insures that forms are available at LSF meetings. Maintains confidentiality of member data.

GAYLACTIC NETWORK REPRE-SENTATIVE: Reports to Network about club activities. Reports to club about Network activities. Reports Network business to the club for voting. Reports club votes on Network business to the Network.

SECRETARY: Insures that minutes are taken at all regular monthly LSF meetings. Maintains archives of minutes and a separate archive of business proceedings. Makes these archives available on request. Provides meeting reports to *The Washington Blade* on request. Creates, updates, and makes available a quarterly calendar of upcoming LSF events. Completes and sends all required business forms for LSF activities (*e.g.* Pride table paperwork).

# The Rocky Horror Picture Show (Let's Do the Time Warp Again!!)

Hot patootie, bless my soul, was it really 25 years ago? I can remember going to see this film at a movie theatre in New York City called the Waverly. Now, I was familiar with the play because I'd seen it in Greenwich Village about a year earlier and always thought that it would make a great fun movie. This particular night was the "midnight movie premiere" of *Rocky Horror* and so it was still fairly sedate; all of the comments and "goodies" tossed at the screen hadn't yet become endemic to watching the movie.

Allow the lips to recap for you, as they open the proceedings with "Late Night Double Feature": In the sleepy town of Denton, OH, Brad Majors & Janet Weiss have just attended their best friends' wedding and declared undving love for each other with the "Dammit, Janet, I Love You" song. They are driving on this dark & stormy night when their right rear tire blows out -which the narrator/criminologist tells us (and frequently cuts into the action to either propel the plot or explain an action) -- and they seek shelter as they sing "There's a Light -- Over at the Frankenstein Place" and enter the foreboding grounds of the mansion/ castle. The butler, Riff-Raff, and his sister Magenta, the maid, bid them enter, as does the lab assistant, Columbia, by singing the famed "Let's Do the Time Warp Again". As they finish the number, they are greeted by their host, Dr. Frank N. Furter, who explains to them that he is just a "Sweet Transvestite from Transsexual Transylvania" in the process of making a man (literally) who is "good to relieve his...tensions"! Rocky is "born" through a series of horror/sci-fi gadgetry effects and sings, upon meeting his maker, that the "Sword of Damocles" hangs over his head. Pish-tosh! The doctor alays his fears by telling him that "In Just 7 Days, I Can Make You a Man!"

At this point, the bizarre guests (that seem to always be about for the big

musical numbers) decide to leave, when the Doc's last love, Eddie crashes through the deep freezer (where he had been "kept") on his motorcycle, singing "Hot Patootie" and lamenting about lost loves & lives and the simpler days of rock'n'roll. The Doc makes quick work of poor Eddie. In the meanwhile, Janet finds herself drawn to Rocky as she sings "Creature of the Night". Dr. Scott, Eddie's uncle and Brad's biology teacher in high school (and secretly a member of the government group searching for a cadre of extraterrestrials) drops by, looking for Eddie and singing "Und I Didt". (He has a German accent.) They all have supper, where Riff spills the beans, confirming that they are indeed from another world. Janet gets very worried, when Dr. Furter tells her "You'd Better Wise Up, Janet Weiss", at which time the Doc has all the visitors gorgonized. He revitalizes them all in time for the drag queen numbers, "Whatever Happened to Fay Wray?" and (the 3rd most famous tune from Rocky Horror) "Don't Dream It -- Be It!", along with the very lively "Wild & Untamed Thing". But!! Just then, Riff-Raff & Magenta re-enter dressed in their alien garb to declare the Doc's mission a failure and that they are taking over and heading back to the Galaxy Transsexual and their home planet of Transylvania. The Doc sings "I'm Going Home", not realizing that when Riff and Magenta (sporting her Bride of Frankenstein hair-do) said they were going home, they did not include the Doc--<ZAP!>--or Columbia (ditto). Rocky is horrified and picks up the Doc and climbs the RKO Radio Pictures tower (that had served as a backdrop for the drag numbers) and is shot down by Riff, who bids the Earth people adieu and reprises "Time Warp" as the ship/castle/mansion takes off to outer space. Our narrator sums up all in the mighty epilogue about lost loves, lost time, and lost in space at the "Late Night Double Feature Picture Show".

Yes, I know I gave you the whole story; but if by now you haven't

seen Rocky Horror, well, pity you!! It's amazing that this film version at first bombed when it opened in 1975! The advertising department at 20th Century Fox really had no idea how to sell the film; then a new exec decided that midnight shows were the way to go, and the rest is movie history. The stars of the film have become legendary, with only Susan Sarandon (Janet Weiss) and Barry Bostwick (Brad Majors) being "virgins", not having performed in the stage show in either the original London cast or in the American premiere in North Hollywood. Tim Curry (Dr. Frank N. Furter), Richard O'Brien (Riff-Raff AND the author/songwriter of the show), Patricia Quinn (Magenta), Little Nell (Columbia), Meat Loaf (Eddie), Jonathan Adams (Dr. Scott), Peter Hinwood (Rocky), and Charles Grey (Narrator/Criminologist) all became cult actors with immortal status. Some went on to become famous for other roles; some went on to oblivion. The director, Jim Sharman, had helmed the stage show in London, and convinced Lou Adler to produce a film version. Believe it or not, this is a lowbudget movie, not costing even \$1.5 million to make, even with Sue Blane's sumptuous costumes and Pierre La Roche's superb make-up (simple but very effective) -- but netting to date over \$100 million! Not bad for a box office dud, huh?

This film is the stuff fan's dreams are made of and is deserving of it's legendary status. In closing, let me just say, "Let's Do the Time Warp Again!!!!!"

Oh!! In the opening song, there are 12 classic horror/sci-fi films either mentioned or referred to. Do you know what they are? NO, I'M NOT GOING TO TELL YOU!!!!!! Enjoy forever!
